#### **Rodeo Grounds:**

Discussion about turning on the water at the Rodeo Grounds. Yes. Ron will see to having it turned on.

## Library:

Amy Hutchinson of Lake County Libraries asked for justification for the rent raise. There was some discussion of the situation. "\$150 per month is not unreasonable." Shara is to continue her communication with Amy on the subject.

## **Community Hall:**

# Airport:
